- Earnest money in shape of Call Deposit (CDR) @ 2% of total value of Equipment's in favor of Secretary SW,SE & WE Deptt, Government of KPK, Peshawar must be attached which shall be verified from concerned banks and bidders are required to submit their Technical/Financial Bids along with all relevant documents through registered post/courier only, not by hand.*

4. *Last date for submission of bids is 6<sup>th</sup> January, 2020 at 10.00 AM which will be opened on same date at 11:00am in presence of bidders or their authorized representatives (if present) by Purchase Committee.*
5. *The successful bidder shall be responsible for free of cost repair or replacement of all equipment's during the warranty period.*
6. *Successful bidder shall be responsible for supply of Laptops within fifteen days after issuance of supply order to supplier/Contractor will ensure supply within the stipulated period without any damage otherwise call deposit shall be forfeited and penalty shall be imposed as per rules.*
7. *All prices shall be effective till 30<sup>th</sup> June, 2020.*
8. *All applicable taxes shall be deducted as per Government Rules.*
9. *To furnish an affidavit on stamp paper amounting to Rs.150/- duly attested by Oath Commissioner that they or their firm has never been blacklisted/banned by any Government Authority. In case of false statement, legal action shall be taken against the bidder.*
10. *The bidders must have experience in the relevant field and shall furnish a certificate and documents evidence of successful supply of these items to Government/Non-Government recognized entities/Organizations.*
11. *The bidders should have their local offices for repair of equipment's and after sales services during the warranty period, otherwise tender will not be considered.*
