The Directorate of Social Welfare Merged Areas invites sealed tenders from the **Original Manufacturers** for the purchase of Sewing Machines, Wheel Chairs, Tricycles, Commode Chairs, White Canes and Crutches worth **RS: 11.468 Million** (Approximately) under different ADP Schemes on the following terms and conditions:-

TERMS & CONDITIONS:-

1. Sales Tax, income Tax registered Trade Marks Certificate holder **Original Manufacturers** may apply for supply of items to District Orakzai and Sub Division Bannu.
2. The bids of the original manufacturers will be acceptable who have at least five years' experience in supply of the above mentioned items.
3. Single-stage-two envelopes bidding procedure containing separately the TECHNICAL PROPOSAL and FINANCIAL PROPOSAL specified in KPPRA Rules 2014 shall be followed for receiving and processing the bids.
4. The envelopes shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters to avoid confusion.
5. Sealed Tender should reach to the address given below before **10:30 AM** on **09-11-2020**. No tender will be accepted after due date and time. Tender will be opened on the same day at **11:30 AM** in the Office of the Director Social Welfare, Zakat & Ushr, Special Education and Women Empowerment Department Merged Areas Canal Lane near Street # 03, Abshar Colony Warsak Road Peshawar. In case of holiday or due to unavoidable Circumstances on the opening day, tender will be opened on the next day at same time.
6. Call deposit of earnest money @ 5% of the quoted rates must be submitted with the tender documents in favor of the Director Social Welfare Merged Areas along with attested copies of CNIC of the bidder, Sales tax, Income Tax and Trade Marks Certificates, Electricity bills, Gas Bills, Telephone Bills and other documents as mentioned in the tender documents otherwise the tender will not be considered.
7. Conditional and incomplete tender will not be entertained. In case of submission of any fake document, will leads towards rejection of the bid even if the manufacturer qualified technically and financially. Furthermore the Department reserves the rights for legal action.
8. The competent authority may increase the quantity of items upto 15% as given in the tender documents subject to the provision of budget.
9. Successful bidder will be bound to sign an agreement prior to the issuance of supply order.
10. All the admissible taxes will be deducted in bills as per government rules.
11. The successful bidders will ensure the supply of the items on the approved rates to the concerned Merged Areas/Sub Divisions on their own expenses within 15 days after the issuance of supply order.
12. The bidders must present the samples of the items on demand otherwise the bids may be rejected.
13. The quoted rates will be valid up to 30th June 2021.
14. Fluctuation in the prices in market will not affect the successful quoted rates of the bidders.
15. The registered **Original Manufacturers** can get tender documents from the office of the Director Social Welfare, Zakat & Ushr, Special Education and Women Empowerment Department Merged Areas Canal Lane near Street # 03, Abshar Colony Warsak Road Peshawar on the payment of Rs: 1000/- during office timings.
